




This chart shows the total general purpose revenue Watts Learning Center Charter Middle expects to receive in the coming year from all sources.

Of the \$4,735,858.22 in LCFF Funds, \$1,325,355.47 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



Engagement with certificated and classified staff has taken place during weekly staff meetings, and surveys. Engagement with administrators has taken place during weekly Leadership Team meetings.

Watts Learning Center Charter Middle School is a single direct funded charter school serving grades 6-8. The additional LCFF Concentration grant add-on funds were used to hire substitute teachers, contract additional substitute teachers, and hire a Counselor to provide direct services to students especially among our Unduplicated pupils. With the return to in-person instruction, surges in COVID-19 rates, in combination with teacher shortages, it was critical to hire substitute teachers, and contract substitute teachers to maintain continuity of services, and avoid disruptions with instruction for our students.

The community our school serves was detrimentally impacted by the COVID-19 pandemic, and students faced social isolation, food and financial insecurity in addition to the high COVID-19 rates. With the return to in-person instruction, it was critical to provide students with a SEL and mental health supports which resulted in hiring a Counselor, strengthening our Advisory Program, in combination with schoolwide implementation of Positive Behavioral Intervention and Supports (PBIS).

Throughout the LCAP development process, Watts Learning Center Charter Middle School, received input on a variety of programs and services provided to students on the use of one-time federal funds (GEER, CARES-LLMF, CARES/ESSER I, CRRSA/ESSER II, ARP/ESSER III, ELO-G) received intended to support recovery from the COVID-19 pandemic and the impacts of distance learning on students. Due to limitations in LCFF funding, not all expressed needs can be addressed in the LCAP, however this feedback has been considered in the use of additional funds Watts Learning Center Charter Middle School has received.

Watts Learning Center Charter Middle School has engaged and continues to engage its educational partners on the use of one-time federal funds received that are intended to support recovery from the COVID-19 pandemic and the impacts of distance learning on students. Health & Safety: Watts Learning Center Charter Middle School's Safe Return to In-Person Instruction and Continuity of Services Plan is updated every six months. It is the priority of Watts Learning Center Charter Middle School to ensure the Health & Safety of its students, staff and educators and ensure continuity of serves as required by the American Rescue Plan (ARP) Act of 2021, and federal Elementary and Secondary School Emergency Relief expenditure plan. ESSER III funds were used to purchase PPE, cleaning supplies, HVAC maintenance, and implemented strict COVID-19 Health & Safety protocols.

Challenges: there are currently no identified challenges.

Continuity of Services: Watts Learning Center Charter Middle School has implemented some of the actions identified in the ESSER III Expenditure Plan which includes incentive pay to retain teachers and staff to avoid further staff shortages which would impact continuity of services for our students; and contracting with Teachers on Demand – full service educator placement agency.

Challenges: Due to staffing shortages, and lack of qualified applicants the Data & Testing coordinator position remains vacant.

Implementation of the ESSER III Expenditure Plan: Watts Learning Center Charter Middle School has implemented some of the actions identified in the ESSER III Expenditure Plan which is a multi-year plan.

Challenges: Currently, there are no identified challenges.

As a result, all additional funds our school receives are viewed through the lens of the LCAP to determine student needs, and how to maximize fiscal resources to effectively impact and address those needs.

Watts Learning Center Charter Middle School has implemented a Multi-tiered System of Support (MTSS) that focuses on evidence-based interventions to address the academic, social-emotional, and mental health needs of its students. The actions in the Safe Return to In-Person instruction and Continuity of Services plan align to Watts Learning Center Charter Middle School's LCAP which aligns to its MTSS model. The actions funded with ESSER III funds are also in alignment with Watts Learning Center Charter Middle School's LCAP. With the decline in student enrollment, ESSER III funds, and one-time funds provided through the Budget Act of 2021 have been essential to maintaining and ensuring continuity of services to improve student outcomes.

General Information

Watts Learning Center Charter Middle School serves approximately 393 students in grades 6-8 with the following demographics: 81% Hispanic, 15% African American, 1% White, 8% Students with Disabilities (SWD), 19% English Learners (EL), and 97% Socioeconomically Disadvantaged (SED).

The WLC Charter Middle School's mission is to provide a world-class education to inner-city students from low-income families to help them realize their full academic potential and to create a culture of learning in which all stakeholders-students, parents or guardians, faculty, and staff have clearly defined roles and expectations.

The middle school's vision is to make the Watts community synonymous with academic achievement rather than with riots and despair and to produce high-academic achievers who are self-confident, ethical, and motivated to be lifelong learners. Our students will possess proficient literacy skills, math and science proficiency, and technological competence. They will demonstrate knowledge and application of the arts, literature, history and social science, health, math, communication, science, problem solving, and work ethics. They will value friendship, responsibility, cultural diversity, quality of life and the democratic process. They will become well informed and highly aware of our interconnected world in order to pursue higher education and seek a professional career.

The ultimate goal of Watts Learning Center Charter Middle School is to serve as a national model of how public education can provide students from under-served communities, especially, with a strong foundation in order to compete both academically and socially in this 21st Century global economy.

- The Suspension Rate Indicator reflected an overall blue performance level schoolwide and for all numerically significant student groups English Learners (EL), Socioeconomically Disadvantaged (SED), Students with Disabilities (SWD), and African American, and a green performance level for the Hispanic student group.
- The Math Academic Indicator reflected a green performance level schoolwide and for the Socioeconomically Disadvantaged (SED), African American, and Hispanic student group.
- The ELA Academic Indicator reflected a green performance level for the Hispanic student group.

With the return to in-person instruction, Watts Learning Center Charter Middle School provided all teachers and staff with robust professional development to support teacher and student needs.

Suspension Rate: Watts Learning Center Charter Middle School successfully implemented Alternatives to Suspension with discipline resulting in no suspensions for the 2021-22 school year. Teachers delivered daily lessons in SEL and PBIS on empathy and emotional regulation, which provided students with the tools to effectively manage and respond to an emotional experience. In addition, teachers/staff have implemented restorative practices, increased counseling services, and PBIS rewards. Advisory courses included a focus on mental health. Watts Learning Center Charter Middle School provided students with wraparound services to address academic, social-emotional, behavioral, and mental health needs.

i-Ready Assessments: This is the first year of implementing i-Ready assessments, a transition from NWEA MAP assessments, and the learning platform to deliver targeted lessons; and differentiate and individualize lessons for students. The State Board of Education (SBE) has approved Curriculum Associates i-Ready Assessments as a verified data source. i-Ready is a comprehensive assessment and instruction program that empowers educators with the resources they need to help all students succeed. By connecting Diagnostic data and Personalized Instruction, i-Ready reduces complexity, saves educators time, and makes differentiated instruction achievable in every classroom for each student. i-Ready provides user-friendly dashboards and reports with actionable data that provides teachers with a foundational understanding of each student's strengths and areas of need. i-Ready's online lessons provide tailored instruction and practice for each student to accelerate growth.

Academic Intervention: To support our struggling learners, Watts Learning Center Charter Middle School implemented "academic mentoring," a course focused on tutoring, and an opportunity for students to complete assignments and/or projects. Saturday School was offered virtually to provide additional academic support for our struggling learners as identified using i-ready assessments. Students were assessed and transitioned in/out of Saturday school in 5-week cycles based on student needs. Chromebooks and/or Wi-Fi hotspots were provided to students who lacked a device and/or internet connectivity.

Over the past two years, the community (students/caregivers) that Watts Learning Center Charter School serves was significantly impacted by the COVID-19 pandemic and faced - anxiety, trauma, job/housing/food/financial insecurity, high infection rates, lack of access to medical care, social isolation, and regression in social skills. Our students experienced significant learning loss as a result of remote learning and the impacts of COVID.

Chronic Absenteeism rates: Watts Learning Center Charter Middle School experienced a dramatic increase in chronic absenteeism rates of 38% in 2021-22. An analysis of absences revealed they were predominately due to the school's strict COVID-19 Safety Plan –

in adherence to state and county health department guidelines, modified quarantines, infection rates, and fear from families that were impacted by the pandemic. Attendance will be incentivized (PBIS rewards) and addressed at parent meetings/workshop. The Attendance clerk will contact families and hold attendance meetings.

Watts Learning Center Charter Middle School has implemented a systemic, continuous improvement framework in which data-based problem-solving and decision making is practiced across all levels of the educational system for supporting students. MTSS is an integrated, comprehensive framework that focuses on the Common Core Sate Standards, core instruction, differentiated learning, student-centered learning, individualized student needs and the alignment of systems necessary for all students' academic, behavioral, and social success. MTSS has a broader scope than does Response to Intervention (RtI), because MTSS includes focusing on aligning the entire system of initiatives, supports, and resources and systematically addressing support for all students, including gifted and high achievers.

MTSS enables a paradigm shift for providing support and setting higher expectations for all students through intentional design and redesign of integrated services and supports, rather than selection for few components of Rtl and intensive interventions. It endorses Universal Design for Learning Instructional strategies, so all students have opportunities for learning through differentiated content, processes, and product. MTSS integrates instructional and intervention support so that systemic changes are sustainable and based on the Common Core State Standards aligned classroom instruction. Through MTSS, our school is challenging all school staff to change the way in which they have traditionally worked across all school setting.

- *ELAC/DELAC and EL-PAC:* meetings took place virtually via Zoom with the Director, Assistant Director, and Parent Coordinator: These meetings focused on school data and then input for how to meet the needs of the students and our school. Follow up to parent concerns/suggestions were addressed in the following meetings. (October 20, 21; November 19, 21; January 19, 22; February 16, 22; March 23, 22)
- Parent Advisory Committee (PAC) including parents of UP and SWD: Took place bi-Monthly Virtual Meetings during Coffee with the Director on the third Thursday of each month and during Parent Council on the third Wednesdays of the month. Action 6: Counselor position was filled in late October 2021. Lion's Den program was not implemented this year.

With the CDE's suspension of the Fitnessgram for the past 2 years and a modified assessments in the current year, this Priority 8 metric will be eliminated on the LCAP.

With the return to in-person instruction and as part of our annual comprehensive needs assessment through the analysis of i-Ready Reading & Math assessment data, schoolwide/student group data, we identified academic achievement gaps among Unduplicated Pupils.

Consistent with the requirements of 5 CCR Section 15496(b), increased services that are contributing for Unduplicated Pupils (UP); and are principally directed towards and effective in meeting the academic needs of Unduplicated Pupils (UP) and are provided on a schoolwide basis which include:

- Goal 1, Action 1: Substitute teachers will be employed to maintain continuity of instruction and avoid disruptions in learning. Watts Learning Center Charter Middle School will provide its students with 180 instructional days which exceeds the CA state requirement of 175 instructional days. All teachers will participate in 10 days of intensive Summer Professional Development, to prepare for the 2022-23 academic school year, and an additional 5 non-instructional days during the academic year for professional development to focus on data analysis. All teachers will also participate in weekly Professional Development and/or staff development.
- Goal 1, Action 3: An area of concern is student performance in Math as identified on the CA Schools Dashboard and student performance on i-Ready reading and math assessment demonstrating significant learning gaps.

To further accelerate student learning, address learning gaps and provide additional academic support, our students will have access to a comprehensive system of supports that includes Instructional Aides will provide tiered small group instruction for struggling learners. LCFF S&C will be used to increase the number of services (academic intervention staff) and will supplement federal funding

- Goal 1, Action 6: Our school is committed to providing and strengthening social-emotional supports through schoolwide implementation of SEL in combination with PBIS. An area of concern is the high chronic absenteeism rate of 38%. The Assistant Director will oversee PBIS implementation, address student behavioral issues/discipline, and provide tiered support. The Counselor and Dean of Culture will provide SEL counseling services, oversee SEL implementation and provide SEL workshops for parents. The Counselor will also participate in professional learning Crisis Prevention Institute (CPI); and provide staff training on de-escalation techniques, developing behavior repertoire with students and implement: EmpowerHer -for at-risk students designed to build resilience, empowerment, and provide a safe space.
- Goal 2, Action 1: An instructional coach will be hired to assist with coaching teachers to improve the quality of the delivery of their lessons to improve student outcomes.

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). The LCAP development process serves three distinct, but related functions:

- Comprehensive Strategic Planning: The process of developing and annually updating the LCAP supports comprehensive strategic planning (California Education Code [EC] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data.
